

# Minutes of Portland Friends Monthly Meeting November 3, 2013

Portland Friends Meeting for Business began in silent worship with 15 members and attenders present. During the silence, co-clerk Anne Harwood read Query #12 from the Revised Advices and Queries. Query #12 reads, "Do you listen for the Spirit even when the words are foreign to you? Is your own understanding of God enriched by other people's experiences of the Divine?"

Clerk's Comments Following the words of the query, Co-Clerk Anne Harwood remarked on the radical nature of our process for business, the need to listen for the spirit. She noted this works best in silence and asked Friends to be mindful of that and proceed in good order.

- 1. We found the minutes of our October meeting to be in good order.
- 2. **Treasurer's Report**. Treasurer Kathy Beach reported that we are ten months, or 83%, into the budget year. Income for October was \$8,388, and expenses were \$7,433, resulting in a positive balance of \$955 for the month. Income year-to-date is \$44,297 and expenses are \$51,691, leaving a gap of \$7,394, which needs to be closed by contributions in November and December.

3. **Financial Oversight.** Rita Clifford began the Committee's report and recommendations in regard to a proposed loan to the Friends School of Portland to support their new building. She described the October 20 information and threshing session, followed by worship sharing, and the general feelings which emerged. Friends believed it was necessary to conserve our money, but also to use it wisely, and support of Friends education is a very wise use. The committee therefore recommends as follows:

"The Financial Oversight Committee of Portland Friends meeting recommends offering a loan to the Friends School of Portland, should it be needed, to help finance the construction of the new school building as it moves to a new location in Cumberland, Maine. The terms of the loan would be \$100,000.00 for a five years, payable over a twenty year period, with the interest and amount able to be re-negotiated at the end of the initial five year period. The initial amount of interest to be charged will be 4 % per annum. The payment schedule is to be negotiated with Friends School of Portland."

Sara Jane Elliott distributed a list of account balances as of October 17, 2013. She described two sets of accounts, the bank accounts and the investment accounts. Among the bank accounts is the Barbie Potter Pax Money Market fund of approximately \$100,000. It is this fund which would furnish the loan. It presently earns less than 1/2 per cent, so a loan with 4% interest would be an improvement.

The mechanics of the proposed loan were explained by Doug McCown. They are as stated in the recommendation. At the end of five years some of the principal will have been paid, but not all. Payment of the balance will then be renegotiated. This could benefit the Meeting if interest rates go up. The Committee chose 4% as a fair rate based on conversations with local banks. Some Friends felt the rate was high if we really want to support the school. It was pointed out that the risks of loaning this money include no repayment at all or only partial repayment of principal, and loss of income if interest rates go up. Even though we would be charging a rate similar to those charged by banks, our loan will help the School be able to use our support as a plus to attract other contributors. It was suggested that we accept the proposal, with the interest rate to be negotiated, perhaps at 3.5%. Friends decided to approve the loan for \$100,000 on the terms described in the recommendation, with the Committee to settle upon an appropriate interest rate and designate the people to negotiate with the School. The Committee will bring its final recommendation to Meeting for Business in December.

4. **Retreat Committee.** Muriel Allen read a report on the all-Meeting retreat held October 5 and 6 at the Notre Dame Spiritual Center in Alfred. The reviews of the place and the activities were positive, and the committee looks forward to a similar event in October 2014. It is close enough that many attenders came for the (cont-)

day. There is growing room in Alfred for more attenders, especially children, and room on the committee for more people. If you are interested, please see Lyn Ballou or Margie Schoeller.

The retreat finished \$277 the black, thanks to its attenders and an equalization fund.

- 5. **Ministry and Counsel**. Stephanie Richards reported. The committee recommends for junior membership Caroline McKeon of Falmouth, who has already made an impact both at our Meeting and in the wider Quaker world, including time at the Kakamega Orphanage. Friends approved.
  - Stephanie reported that the Committee is working on the idea of a memorial wall, which would consist of photographs of deceased members, allowing members and attenders new and old to remember those we miss. If you have thoughts about this project, please see a member of Ministry and Counsel.
- 6. **Youth Religious Education**. Caroline McKeon announced a fundraiser for the Meeting November 24 after the rise of Meeting selling homemade pies and a vegetarian lunch. If you are interested in making a pie, please see Lise Wagner.
- 7. **Good Search**. Kathy Beach reported that Financial Oversight Committee is considering having the Meeting participate in the benefits of this search engine. The Friends School of Portland already uses it to enable people buying on line from certain sellers to allocate part of the profit from their purchase as a contribution to a designated charity. Friends approved of proceeding to include Portland Friends Meeting. It was suggested that the Committee put an article in the newsletter instructing Friends on how to use Good Search to benefit the Meeting.
- 8. **Nominating Committee.** Rob Levin reported the Committee is hard at work on positions for 2014 and urged Friends to sign up for vacant slots on the sheets posted in the lobby. The Committee is pleased to recommend Andy Grannell as Co-Clerk of the Meeting. Friends approved. Friends thanked Anne Harwood for her excellent service as Co-Clerk.
- 9. **Quarterly Meeting.** Marlee Turner reported on the October 26 Quarterly Meeting at Windham, in a church even older than ours. Brian Drayton of Weare Meeting gave the program about recording gifts in ministry and was joined by some of the recorded ministers in Falmouth Quarter: Edwin Hinshaw and Clarabel Marstaller of Durham, Janice Beattie of Windham and Ralph Greene of South China. Daphne Clement of Durham and Christa Evans of Brunswick will co-clerk the rejunvenated Ministry and Counsel Committee. Dorothy Grannell will serve as Clerk, Colleen Crowley as Recording Clerk and Leslie Manning as Treasurer.
  - The Quarter has begun the process of laying down Oxford Hills Meeting. They have set new quarterly meeting dates of the 4th Saturday, but this July will be the 4th Sunday because of the 200th anniversary of Quaker Ridge Meeting.
- 10. **Events Committee**. Dorothy Grannell reported a checklist is almost complete and there will be a training session on January 12, 2014 at the rise of Meeting.
- 11. **Other business.** Youth Religious Education will do the Advent Garden on Sunday, December 1 at 4 p.m. Anne Payson, Youth Religious Education Coordinator, noted that it is the Sunday of Thanksgiving weekend.

We closed in silent worship at 10:25 a.m. with 29 members and attenders present, purposing to meet again at 9 a.m. on December 1, 2013, God willing.
