# Portland Friends Meeting Minutes of Meeting for Worship for the Conduct of Business December 3, 2023

We began at 12:18 p.m., gathered in person and also connected via Zoom. There were 45 members and attenders present for this meeting.

Mags Fehr read the following passage from Braiding Sweetgrass by Robin Wall Kimmerer:

"Today is the third grade's turn. There are only eleven of them and they do their best to start together, giggling a little, and nudging the ones who just stare at the floor. Their little faces are screwed up with concentration and they glance at their teacher for prompts when they stumble on the words. In their own language they say the words they've heard nearly every day of their lives. Today we have gathered and when we look upon the faces around us we see that the cycles of life continue. We have been given the duty to live in balance and harmony with each other and all living things. So now let us bring our minds together as one as we give greetings and thanks to each other as People. Now our minds are one."

- **1. Minutes from November 5, 2023 Meeting for Business.** Friends accepted the minutes as printed in the newsletter, with one deletion of a line from the Welcoming Committee Report, namely "promote meeting members and attenders."
- **2. Acceptance of Transfer of Membership Request.** Friends accepted Diana White's request for transfer of membership to Durham Friends Meeting, with appreciation for what she has brought to our meeting .
- **3. Treasurer's Report.** Kathy Beach, Treasurer, reported on our historical pattern of increased giving at the end of the calendar year, with thanks. She reminded us of the numerous opportunities that Friends have to give all year long. All pledges to outside organizations have been met, including to New England Yearly Meeting. There is a deficit at the moment, although enough resides in the checking out to pay current bills. The Shared Witness Fund is now at \$172,000, through Friends Fiduciary. To the great delight of the committee (and Kathy!), Dick Stratton has agreed to step in for a year as co-Treasurer, along with Jane Mullen, who will continue to take in the donations. Gratitude was expressed for the committee making the arrangements to move our accounts from TD Bank to Norway Savings Bank. Friends expressed appreciation to Kathy for her many years of excellent service.
- **4. Consideration of the 2024 Operating Budget.** Jo Linder, clerk of the Financial Stewardship Committee, reported. The proposed budget for 2024 was outlined, reflecting changes based on thoughtful comments after last business meeting.

The committee is pleased that there will not be a need to hire a bookkeeper, since Dick Stratton will be coming on as co-Treasurer.

The committee's proposed budget reflects a deficit and inquires of Friends whether that budget can be approved or whether Friends agree to add to the Donations line (\$11,930) to balance the budget. The committee noted that not all committees or other lines (such as Leadings Grants this year) use the amounts listed in the budget. One person noted that although this appears to be a 'deficit' budget, it is rare that all budgeted expenditures are actually spent, cautioning against making any significant changes due to a concern for a real deficit. Friends were reminded that this proposed budget has less in each line for the two youth coordinators, which may not be the same in the future.

One Friend raised a concern that there is a disproportionate amount allocated to the Velasco Friends Sister Committee, compared to allocations for local needs. Others suggested that local spending is more important. Friends were reminded that the Shared Witness Fund could also support other causes, requesting that folks bring their ideas to the conveners of the Fund. The Clerk noted that the meeting agreed to continue its relationship with Velasco Friends Meeting, and is a shared witness of the meeting. We were reminded that this experiment will be reviewed in 2025.

One Friend raised a concern about donations not keeping up with planned operating expenditures, relying too heavily on the investment funds to make up the difference. One Friend views the support of the Velasco Sister Committee as walking together as Friends in the world, belonging in the operating budget rather than in the Shared Witness Fund. Our incoming co-Treasurer invites us to live into this proposed budget, anticipating that 2023 will not end with a deficit. The Clerk noted that we might benefit from further analysis of the trends in spending over several years, in order to come to more realistic estimates, similar to the analysis of the patterns of giving. We also need more discussion of what belongs in the operating budget and what is better addressed by the Shared Witness Fund.

**Minute: Friends approved the proposed budget.** Two Friends requested to be minuted as standing aside.

**5. Shared Witness Fund: Support of Bolivian Friends.** Paula Rossvall began by reminding us that Emma Condori Mamani came to us in July 2023, glowing with Spirit, and told us about the dire climate situation affecting the ability of indigenous Quakers in Bolivia to grow their own food. Dorothy Grannell and Beth Bussiere-Nichols joined her.

The request is for \$10,000 from the Shared Witness Fund for Friends International Bilingual Center, which has taken on food security for those Friends. This will also assist in changing ways of farming, among other things

Friends heartily approved the request.

**6. Proposal to Change Time of Meeting for Worship.** Mags Fehr of Ministry & Counsel reported on the proposal to change the time of meeting for worship to 10 a.m., with early worship on third Sundays from 8:45-9:45 a.m. Among other things, the earlier time for Meeting for Worship will allow for activities following the rise of Meeting without extending too far into the afternoon.

Friends approved the change in time of Meeting for Worship to 10 a.m., to begin in January.

### MESSAGE FROM THE YOUTH RELIGIOUS EDUCATION COMMITTEE

The Youth Religious Education Committee (YREC) seeks a new YRE Coordinator to begin with the new year.

The coordinator is the face of the Portland Friends community for families and collaborates closely with the YREC team to provide a rich variety of connections and learning opportunities for the youth of the Meeting and their families. The position requires, on average,



8 hours per week of commitment and includes compensation. The position has some flexibility to match the needs or leadings of the person in the role. Further details can be found in the following job description.

#### Job Description: Youth Religious Education Coordinator

The Youth Religious Education (YRE) Coordinator is the face of the Portland Friends community for families and the foundation of the Youth Religious Education Committee's (YREC's) work building and maintaining strong relationships between families and Portland Friends Meeting. The YRE Coordinator collaborates closely with the YRE volunteer team to provide a rich variety of connections and learning opportunities for the youth of the Meeting and their families. A substantial (but not exclusive) responsibility of the Coordinator is the support of the First Day Youth Program.

The work of the coordinator may vary with the time of year, but the position requires, on average, 8 hours per week of commitment. In recognition of the significant investment and commitment required by the position, the Meeting provides the Coordinator with a compensation of \$22 per hour for 8 hours per week. All work of the Coordinator is under the guidance and grateful support of the Youth Religious Education Committee (YREC).

A typical week for the Coordinator often involves:

- Communicating with last week's volunteers and this week's volunteers.
- Writing to families about upcoming events.
- Preparing and delivering materials for Sunday's program.
- Recruiting volunteers for future Sundays.
- Collaborating with meeting members and clerks around supporting families.
- Updating the attendance and budget as needed.
- Some reflection and reporting about the program
- Research into the activities of other meetings and regional offerings

While not a requirement, previous coordinators have found that attending Meeting for Worship at least twice per month supports them by helping to build and maintain important connections. Finally, both the committee and the coordinator recognize that the lasting effects of the COVID 19 pandemic continue to require a spirit of exploration and adaptation in this work.

#### **Responsibilities:**

- 1. Greet new families with children.
- 2. Build relationships with families and connect them to the meeting community. Inform families about nursery care, youth program, annual events, fall clean-up, and regional Quaker programming.
- 3. Support the Youth Program and Nursery
  - a. Coordinate volunteers and support the Nursery Coordinator, providing plans, materials, snacks, substitutes and problem-solving.
  - b. Maintain attendance records and contact info for families
  - c. Keep a record of the general activities of the youth program
  - d. Maintain spaces used by children, and tend to safety and tidiness
  - e. Ensure organization of the youth program materials
  - f. Ensure that background checks are conducted for all volunteers
- 4. Attend monthly YREC meetings
- 5. Coordinate with the clerk to provide a report about YRE activities Meeting for Business (MFB) several times per year
- 6. Coordinate PFM scholarship applications for youth programming like Friends Camp, Friends School camp, Youth Retreats with families and the committee.

To provide understanding of how the Coordinator's role fits into the YRE team, the following descriptions are also provided:

#### **Teacher and Youth Program Volunteer responsibilities:**

- Welcome and work with children and youth during First Day youth programs.
- Use tools provided by YRE Coordinator, and add on as inspired.
  - Tools include: games, songs, crafts, and books to support spiritual experience and an understanding of Quaker life.
- Communicate with YRE coordinator about issues of concern.
- Report to the Coordinator about attendance.

#### **Committee member responsibilities:**

- In collaboration with the YRE team and Meeting: offer a general structure of First Day School and coordination between the age groups
- Attend Meeting for Business (clerk and coordinator)
- In coordination with YRE team, support the creation of materials, curricula, and lesson plans
- Provide coverage for teacher and coordinator responsibilities during absences as needed
- Recruit teachers and coordinators
- Oversee the needs of the nursery
- Provide relevant information to the PFM newsletter (clerk)
- Ensure safe, clean environments that meet child safety guidelines
- Keep committee documents organized and accessible (clerk)
- Plan and carry out our yearly all-meeting events focused on youth
- Support the Meeting to incorporate youth into the meeting's other work and events

#### **Nursery Care Provider Needed**

The Youth Religious Education Committee of Portland Friends Meeting continues to seek a Nursery Care Provider to begin in the new year.

The Nursery Care Provider provides childcare every Sunday from 10:15 am to 12:15 pm for infants and children too young (generally 5 years old and under) to attend the youth program of Portland Friends Meeting.

To offer a consistent face to the Meeting's youngest children, applicants who can commit to working most Sundays are preferred, but other arrangements will be considered. Prior participation in Portland Friends Meeting is not a requirement of the position, and Friends are encouraged to share the details of this position with appropriate people in their wider community who may be interested. #### **Friends General Conference Gathering**

This is the first Gathering in 50 years in the Philadelphia area, so planning ahead is a good idea.

Friends General Conference, with Divine guidance, nurtures the spiritual vitality of the Religious Society of Friends (Quakers) by providing programs and services for Friends, meetings, and seekers. The Gathering is a week of Quaker worship, workshops, and community for all ages. Friends come together from across the US and Canada (and sometimes further) to deepen our connection to one another and the Spirit. The Gathering is typically held on a college campus in late June/early July, and location changes from year to year.

Gathering attenders range from newborns to elders in their 90s, and include both long-time Friends (mostly from the unprogrammed, liberal tradition), and those newer to Quakerism. In structure, it's part conference and part family camp. In content, it provides an abundance of opportunities to learn about Quakerism and to foster your spiritual life – and to have fun together.



## Friends Committee on National Legislation (FCNL) Urges Action on Palestine-Israel

## The U.S. Must Act to De-Escalate the Violence in Israel and Palestine

We are heartbroken by the recent violence in Israel and Gaza. As Quakers, we deeply mourn the loss of all lives and pray for those who have lost loved ones due to this latest escalation. We unequivocally condemn Hamas' attacks and inhumane treatment of civilians and call for the immediate release of all hostages. We also condemn the indiscriminate and violent Israeli response that has already claimed hundreds of civilian lives.

## More war and weapons won't bring peace. In the face of growing violence, lawmakers must:

- Work to de-escalate this situation by calling for restraint, ceasefire, deescalation, and respect for international law.
- Protect lives—those of the Israeli hostages and the roughly 1 million children who live in Gaza.
- Address the root causes underlying this explosion of violence, including decades of institutionalized oppression and collective punishment of Palestinians through brutal military occupation and a 16-year Gaza blockade.

Urge Congress to call for an immediate ceasefire, de-escalation, and restraint to prevent further civilian harm in Israel and the occupied Palestinian territories.
